Donna began teaching the basic computer classes and has five students. She has two more internet e-mail classes scheduled for this month. On January 24th and February 27th, Betsy Brooks and Chad Chase from CEF were visiting the Library again to discuss e-books. Donna attended a workshop last year and because she started the computer classes within six months of the training was able to get a \$150 incentive for the library, so she submitted an application to get that money. She is hoping to schedule some more computer classes for the month of March.
