PUBLIC WORKS/ELECTRIC:

Brian Pelkey, PWS stated that there have been four (4) accidents in the village, (3 light poles and 1 transformer). Brian is working with the insurance companies. He stated that bills have been sent out. The insurance company pays for all labor, materials and call out.

Brian stated that the Electric Department is waiting on secondary wiring to finish on Chapman from Delaware to the tracks. Brian also stated that from Delaware to Maple Street has all been energized. Five (5) photoeyes are being replaced on some of the Christmas decorations.

Brian also stated that the Street Crew is doing building maintenance as the weather permits. They will be replacing the ½ moon windows in the attic at the Library with plexi-glass. Brian asked that if any of the Departments have maintenance that need to be done to let him know. He also stated that the equipment is all set and ready to go. Also, the yard behind the Blue Building is all cleaned up.

COMMENTS FROM THE PUBLIC:

John Cooper asked for clarification regarding the Barton & Loguidice proposal for a study on the Water Plant upgrades. There appears to be some confusion as to the amount of money that is being charged for the Study.

The \$20,000 is a lump sum amount for the Study. Payments on the \$20,000 may be made monthly. There is no indication as to the amount of time it will take to do the study. There are grants that Barton & Loguidice will apply for at the end of the summer.
