

Minutes of the Regular Meeting of the Board of Trustees of the Village of Rouses Point, New York held on July 15, 2024, at Halstead Hall, Civic Center, 39 Lake Street scheduled to commence at 7:00PM.

3. Trustee Arno stated that there is a lady hanging around the gazebo. Administrator Latremore stated he will investigate.

D. TRUSTEE BRIAN S. PELKEY:

1. Trustee Pelkey thanked for the assistance from Public Works, Wastewater and Civic Center during the power outage. Trustee Pelkey stated that with their assistance, it made his job easier getting the power back online. Trustee Pelkey stated that all departments work extremely hard and appreciate their help.
2. Trustee Pelkey stated that the boat launch is remarkably busy. Trustee Pelkey has observed that cars are parked in the area designated for vehicles with trailers. Trustee Pelkey suggested that the village paint lines in the parking lot show the designated parking area. Longer spots are for vehicles with trailers and the shorter spots are for regular parking. Trustee Pelkey stated that if this does not work, then the village will have to put up signage.

VOTED, AYE.


