SHORT SITE PLAN REVIEW

Site plans vary according to magnitude, complexity, and impacts. The detail required on the Site Plan depends upon these factors. However, there are some basics required for all Site Plans. The Zoning Enforcement Officer at the time you apply will indicate which of the following you will need for your particular plan. The Planning Board may require additional information they feel necessary prior to granting approval.

The following are items needed for, but not limited to, acceptance of your Site Plan:

- A. North arrow indicator
- B. Perimeter boundaries of the parcel- distances must be in linear feet
- C. Size and location of all buildings on site
- D. Setbacks of all structures
- E. All parking spaces or areas must be shown. Parking space= 9' x 18'
- F. Outline of intended expansion or location of the project site
- G. Indicate every delivery entrance
- H. Show and detail surface water drainage system
- I. Show driveways, indicate length and width
- J. Draw location of trees and intended natural screening, e.g. private hedge
- K. Show by size all existing and intended buffer zones
- L. Show location, size, and type of any exterior signs
- M. Show location and intended screening for bulk trash receptacles
- N. Indicate type and location of intended exterior lighting
- O. Show scale of drawing
- P. Show abutting streets/roads by name, also Right-of-Ways involved
- Q. Show distances to road intersections, both directions
- R. Indicate traffic control measures intended for this site
- S. Show names of landowners of abutting properties
- T. Indicate type of paving for driveways and parking areas

An initial Sketch Plan of the Site should be submitted on white paper, approximately 20"x20", drawn to scale (1/4"= 1" preferred for smaller, less complex projects) and include all basic information called for.
