Questions from the Council 1. If we need cyber insurance- it covers if computers get hacked and compromised- covers HIPA, email lists, and if data gets compromised. Dolores, Lon and Don

didn't see the need since most of the Village info is public. 2. Legal services are provided by both companies- Bone and Bailey 90 min free legal counsel free per 1/4 -leuter no time limit. 3.Both Companies Bond -Bone and Bailey \$25,000- leuter \$100,000 Blanket. 4. Park Injuries fall under general liability. League Play falls under League Insurance. 5. Both companies cover \$5 million if elected official gets sued.
