- Mitchell St. (home with no roof/tarp) -Brett spoke with Midland Co on the issue of the house to condemn/tear down. House could be condemned but may still stand. Midland uses property maintenance code and their attorney to deal with condemnation and removal. Village will cite with Blight Code 39 sec. D. Letter will be sent to property owner and proceed from there.
- Ferro St. (cars parked at end of road & long grass)-Letter was sent, area has been checked on and cars are still being parked on the road. Residents advised to call the sheriff's office and have them towed. If there is a fire hydrant at the end of the street, cars that are parked may be in violation of being parked too close to the fire hydrant as well. Dolores to see if there is a fire hydrant at this location. Pics of violation have been taken.

- Cass St. (blight & scrap-metal business)- They are working on cleaning up front and back yard. At a check of progress, they were informed that if the yard is clean and fines paid, they can cancel Wed. Oct 14th court date. They were notified property must remain clean and no scrapping can resume, or they will be cited again. They were also given a warning that trucks parked on the property all needed to have updated license plates or citation will be issued.
