Operation of Golf Carts



Utility Vehicle



1. Licensed driver
 2. Slow Moving Emblem with reflective surface
 3. D.O.T. approved operational head lamps, D.O.T approved side reflectors
 4. Rearview Mirror(s)
 5. Operational parking brake
 6. No driving on walking/bicycle lane on Tiki Dr.
 7. Drive with the flow of traffic
 8. Liability insurance (optional)
 9. Children under the age of seven shall be restrained by either an Adult or a seatbelt
 10. Golf carts prohibited from pulling trailers, boats, jet skis, other objects or people on public streets and the right of way.
 11. Headlights shall be used at dark beginning 30 minutes before sunset and 30 minutes after sunrise.
 12. No one shall stand in or on the vehicle while it is in operation.
 13. The number of golf cart passengers shall not exceed seating capacity designated by the manufacturer.
 14. All golf carts shall be registered with the Village and have attached registration sticker issued by the City Fee of \$25.00, renewal \$15
 15. In any case that you trailer your golf cart for use off Tiki Island, most likely you will need a license plate.
 16. All drivers shall abide by all traffic regulations applicable to vehicular traffic when using authorized streets
- Village of Tiki Island Ordinance 40-121 thru 123**

1. Licensed driver
 2. No driving on walking/bicycle lane on Tiki Dr
 3. An unaltered muffler system
 4. Seatbelts for driver & all passengers
 5. An unaltered spark arrestor
 6. Rear view mirror(s)
 7. Slow Moving Emblem with reflective surface
 8. ATV's prohibited from pulling trailers, boats, jet skis, other objects or people on public streets or right of way
 9. All Utility vehicles must use head lights when operated 30 min before sunset and 30 min after sunrise
 10. The number passengers shall not exceed seating capacity designated by the manufacturer
 11. No one shall stand in or on the vehicle while it is in operation
 12. All Utility vehicles shall be registered with the Village and have attached an annual registration sticker issued by the City upon payment of a \$25.00 registration fee
 13. All drivers shall abide by all traffic regulations applicable to vehicular traffic when using the authorized streets
 14. Drive with the flow of traffic
- Village of Tiki Island Ordinance 40-130 thru 134**

The biggest violations are: **The unlicensed, under-age drivers and open containers of alcohol.**
