### MEMORANDUM

A "DEPOSIT" of \$ 215.00 is required on all accounts to be paid before service is connected.  
-\$200.00 is your "REFUNDABLE DEPOSIT" that remains in customers' account until this service is final at the service address on Tiki Island.  
-\$15.00 of the amount above is for administration fees (charge in setting up new account for service).

Services are billed for a minimum of 3,000 gallons of water and 3,000 gallons of sewage treatment. (3,000 gallons are as noted on water/sewer bills as 3.0).

**These charges are based on a standard 3/4" meter.**

MINIMUM CHARGES ARE AS FOLLOWS: (based on standard size meter)

Water	\$20.00	(minimum rate for 0.0 to 3.0 gallons)
Sewer	\$22.00	(minimum rate for 0.0 to 3.0 gallons)
Emergency Svc	\$42.00	(Mandatory Emergency Service Fee)
Police Donation	\$ 2.50	(VOLUNTEER DONATION-Fire & Security Fund)
<b>TOTAL</b>	<b>\$86.50</b>	<b>(TOTAL MINIMUM BILL with donation)</b>

The additional cost over minimum for *WATER* is \$3.90 per thousand gallons up to 8000 gallons (8.0), from 8.1 to 12.0 is \$4.90/thousand, from 12.1 to 16.0 is \$5.90/thousand and usage over 16.0 is \$6.90/thousand.

The additional cost over minimum for *SEWER* is \$1.50 per thousand gallons up to 8.0, from 8.1 to 12.0 is \$2.00/thousand, 12.1 to 16.0 is \$2.50/thousand and usage over 16.0 is \$3.00/thousand.

You are billed for the previous months' water usage. The meters are read on the 22nd of each month. There is a \$15 penalty (or 10% of balance) if payment is not received before or on the DUE DATE, which is the 20th of each month, which appears at the bottom of your stub.

There is also a Reminder Notice sent after an account is in arrears (ARR.) / past due for 30 days.

Other Charges are as follows:

RETURNED <u>INSUFFICIENT CHECK</u> FEE .....	\$ 35.00
RE-CONNECT FEE <u>NON-PAYMENT</u> OF BILL (TERMINATION). \$	100.00
RE-CONNECTION FEE FOR <u>STAND BY</u> SERVICE.....	\$ 50.00
