

WATERMAN LION'S COMMUNITY PARK GENERAL RULES

1. All reservations for use of the shelter house must be made through the Village Hall at 815 264-3652. A \$30.00 non-refundable reservation fee must be paid to hold your date. Dates will not be reserved without receipt of this fee. The reservation fee will be applied to the rental fee.
2. Commercial use of the park is **PROHIBITED** without Village approval. **NO EXCEPTIONS!**
3. Shelter house rental fees are as follows:

between the hours of 9:00 a.m. to 10:00 p.m. Please designate hours of rental.
3. Everyone in the park is free to use all outdoor amenities, restrooms, and picnic tables at any time. If you have reserved the south ball field, it is yours exclusively for the day.
4. The Village of Waterman is not responsible for personal accidents or loss of any kind.
5. Please clean up all debris and trash from shelter house and grounds. Please put trash in the dumpster located at the south park entrance.
6. Please leave all tables and chairs in the shelter house. Wipe down and fold all tables and chairs and place on the racks.
7. Sweep the shelter floor.
8. Please lock all windows and doors before leaving.
9. If any items within the shelter are damaged or missing after the rental, you could be liable for the replacement cost of said item and your Security Deposit will be forfeited.
10. Please turn ceiling fans ON and OFF with switch on east wall.
11. Please turn hot water heater on if you need hot water (takes a few hours to heat.) Make sure to turn it off when you leave.
12. If you plan to have an inflatable attraction, this must be disclosed at time of reservation. Proof of liability insurance from the attraction owner must be provided. It must be supervised at all times of operation and removed by the end of your rental period.
13. Use of alcohol must be disclosed at the time of rental.
14. **NO PARKING ON THE EAST SIDE OF THE SHELTER ON THE ASPHALT!**
15. In the event of an emergency, please call 224-489-9432.

REGULATIONS

1. Do not mutilate, deface, or destroy any property. Compensation or replacement will be required.
2. Do not cut, break, or remove any shrub, tree, or flower.
3. Firearms are strictly forbidden in the park.
4. Do not drive or park on the grass.
5. No off-road vehicles allowed on grass without permission.
6. Do not solicit or sell on the park grounds without special permission from the Village Board.
7. Do not dispense or post any forms of advertising.
8. No camping on the park grounds.
9. Waterman Lions Community Park closes at 10:00 p.m.
