INTRODUCTION

Welcome to the Village of Three Oaks 2017 - 2021 Parks and Recreation Master Plan. This plan reflects a vision for the future of Three Oaks' parks and recreation facilities: their operations, maintenance, and enhancements for the next five (5) years. It serves as a roadmap for future recreation facilities and programs by considering existing parks and programs in and around the Village and the anticipated demand for additional or improved recreation facilities.

This Plan also forms the basis for potential recreation grant funding from the Michigan Department of Natural Resources (MDNR) and other agencies and foundations. Three Oaks' Plan was prepared in accordance with MDNR's *Guidelines for the Development of Community Park, Recreation, Open Space, and Greenway Plans.*

Three Oaks' Planning Process

KEY STEPS

The 2017-2021 Parks and Recreation Master Plan was prepared with technical assistance from McKenna Associates, a planning and design consulting firm, and with the active involvement of the Village's Administration and the Three Oaks Parks and Recreation Board.

Citizen input through an online survey and public hearing also contributed to this Plan. Following initial discussion by the Village's Planning Commission and a draft Plan review by the Parks and Recreation Board, the 2017-2021 Parks and Recreation Master Plan was submitted to Three Oaks' Village Council for adoption. Throughout the process, all meetings were open to the public. Notices were posted beforehand, and where required, advertised in the newspaper, as provided by the Open Meetings Act. The planning process kicked-off in December of 2016 and finished with the adoption of the Plan in February of 2017.

This Plan will act as Three Oaks play book for community building as it relates to parks and recreation over the next five+ years.

The Village of Three Oaks prides itself on its park and recreation system as a healthy system affords residents and visitors with a higher quality of life standard. The benefits of creating and maintaining a quality parks and recreation system include:

- Rises in adjacent property values;
- Encouragement of economic development, which in turn, can further attract investment;
- Natural beauty;
- Environmental gains and benefits;
- Social and fun; and
- Sense of place and identity.

The intent of this Plan to afford all members of Three Oaks the opportunity to participate and enjoy in the Village's parks and recreation facilities and to act as gathering spaces for community building.



COMMUNITY SNAPSHOT

The Village of Three Oaks is a traditional small town with an historic core, grid street system, abundant amenities, in southern Berrien County, southwestern Michigan. It is located within a few miles of Lake Michigan and the Four Winds Casino in nearby New Buffalo, both of which attract visitors to the general area. US-12 and nearby I-94 provide access to nearby metropolitan areas of Chicago, St. Joseph-Benton Harbor, and South Bend.

The area that became Three Oaks was initially settled in 1850, with its first businesses serving the rail line between Chicago and Detroit. Originally called Chamberlain's Siding, after founder Henry Chamberlain, the settlement became a Village in 1867 and was renamed "Three Oaks" after three distinctive trees near the railway that engineers used as a marker.

Throughout its history, Three Oaks has been known for its patriotism. In 1899, the community raised \$1,400 for the Dewey Cannon Memorial to the battleship USS Maine, the largest amount per capita of any community in the country. The memorial was dedicated by President William McKinley and other heroes of the Spanish-American War.

Downtown Three Oaks remains the center of most community activities in the Village. With a strong retail base, park space, institutions, and public facilities, it continues to act as a draw for residents and visitors alike. In fact, the 1989 film Prancer, was set in Three Oaks, with much of filming done on location.

Parks near the downtown are also home to special events as Dewey Cannon Park is used during the summer for volleyball tournaments and concerts, and is also the staging area for the Apple Cider Century bicycle race. Three Oaks also hosts an annual Flag Day Weekend Celebration that has been called the largest in the country. In June of 2016, the Village celebrated their 64st annual Flag Day Weekend and hosted the world's largest Flag Day Parade. The Flag Day festival includes a parade and the reading of an original piece by the Village Poet Laureate. Other community events within park areas include Art in the Park and the winter Tree Lighting Ceremony.

In addition to the many assets, festivals, and amenities offered in Three Oaks, the community is ideally situated to take advantage of the abundant historical, cultural, and institutional facilities located in the surrounding communities as well as the abundant natural features and resources.

Administrative Structure

OVERVIEW

Operations, maintenance and improvements to Three Oaks' recreation facilities are the primary responsibilities of Village staff and the Department of Public Works (DPW). Providing parks and recreation opportunities to the community begins at the top with the residents, who entrust these assets to the Village Council and the Parks and Recreation Board, with staff support.

The following entities are the major municipal recreation players within the Village of Three Oaks and described in greater below:

A seven (7) member board, the Council maintains final authority over all recreation facilities.

Parks and Recreation Board

The Parks and Recreation Board is appointed by the Village Council and serves as an advisory body to oversee the management and budgetary decisions regarding parks in the community. Board members meet once a month and include representatives of the community as well as from both the Village Council and the Planning Commission. One member of the Board is also a Three Oaks Township resident which promote crossjurisdictional and regional prosperity.

Residents, Volunteers and Community Organizations

The Village strongly relies on volunteers and community organizations to maintain a quality parks system for Three Oaks. Volunteer citizens not only make up the majority of the Parks and Recreation Board, but also assist with the planning and organization of communitywide events and festivals held within the parks. Contributing organizations include, but are not limited to the Rotary Club of Harbor County, The American Legion, the Masonic Lodge and various Garden Clubs. Their continual investment and dedication to parks is a vital component to the vitality and beautification of Three Oaks' park lands.

In addition, maintenance and upgrades to the facilities desired by the Board are often completed or implemented by volunteers in order to reduce the cost of the project.



Funding

Primary funding for the maintenance and programming of Three Oaks' recreation facilities comes almost entirely from a sub-account of the Village's general fund. Alternative funding sources include donations from individuals / private organizations and grants awarded for specific projects, all of which the Village continues to pursue.

Table 2.1 details the Village of Three Oaks' Parks and Recreation budget expenditures with consolidated categories. During the 2015-2016 fiscal year, the Parks and Recreation budget was \$36,000. Although only 3.56% of the total \$722,095 general fund budget (not including water and sewer funds) for the Village, it does represent an increase from the previous year's budget.

Currently, there is no independent revenue source for parks and recreation (e.g. user fees, millage, etc.) in the Village with the exception of a small amount of funding collected from rental fees for facilities in three of the Village's parks: Carver, Watkins, and Dewey. The vast majority of revenue is transfers from the general fund with only small amounts coming from independent revenue sources.

With a Parks and Recreation Plan in place, the Village Council may consider seeking a millage to help fund the Parks budget. Any decision on whether or not to seek a millage will depend on the fiscal constraints of the general fund and the specific parks and recreation goals expected to be realized both in the near future and long-term.

Grant History

The Village of Three Oaks has not received grants from the Michigan Natural Resources Trust Fund, Land and Water Conservation Fund, Recreation Passport Grant Program, Clean Michigan Initiative Recreation Bond Fund or the 1988 Recreation Bond Fund. However, the Village has graciously been the recipient of grants from Southwest Michigan Realtors, the Pokagon Fund, Rotary District 6360, and the Masonic Lodge. The contributions from these entities have enabled the Village to successfully complete parks and recreation projects and improve the quality of the Three Oaks' recreation system.



GREEN & BLUE FRAMEWORK

Understanding Three Oaks' environmental setting is critical when planning for recreation facilities and the connections between them. The location, topography, and existing environmental features all influence the types of facilities, amenities, and programs that are best suited for implementation.

The Green and Blue Framework chapter describes the benefits and challenges associated with Three Oaks' location and natural resources features. Also included within this chapter is the Village's existing formal park system, with an inventory of the current recreation amenities provided at each facility and a description of recreational facilities that are available outside of Three Oaks. The existing recreational facilities and land devoted to such uses then provides the backdrop for analysis and comparison to MDNR standards to determine where the Village is excelling or may have room for improvement.

Additionally, this chapter follows a holistic, regional approach to environmental quality, transportation linkages, parks and recreation facilities, and other assets. The Village of Three Oaks seeks collaboration with not only Three Oaks Township and Berrien County, but also within the larger region of southwest Michigan.





Natural Features Framework

Three Oaks' green and blue framework highlights the Village's many natural assets including open spaces, waterbodies, and wetlands:

WATERWAYS AND DRAINAGE

There are no significant natural waterways in Three Oaks, except for a few minor creeks on the northwest side of the community. The Schwark Drain, a manmade watercourse built to ease the drainage problems, cuts across the southwest side of town, through Watkins Park. Water in Three Oaks eventually drains into the Galien River and then into Lake Michigan.

Much of the Village suffers from drainage problems, a result of the flat topography of the area. Recently, the Schwark Drain was built on the southwest side of town in order to make the vacant land south of Locust Street more attractive and feasible for development. The drain has improved the flow of stormwater from the south side of the Village, but its construction severely damaged the nature trails at Watkins Park, which are now in need of repair.

WOODLANDS

Since so much of the land around Three Oaks is used for farming, large woods or forests are not common. However, the Village has a healthy number of street trees and other vegetation in its residential districts. Additionally, there are two wooded areas within the community - one at the southern end of Watkins Park, which features nature trails, and one south of Indiana Street, where the Three Oaks Woods subdivision has been built with minimal impact on the tree canopy.

TOPOGRAPHY

The Village and surrounding areas are very flat, the result of glaciers grinding down any roll to the land during the most recent Ice Age. Those same glaciers left southern Michigan and northern Indiana with the extremely fertile farmland that surrounds Three Oaks today. Because of the flat topography, drainage is a problem and the ground often gets a spongy consistency after a rainstorm or snowmelt.

Three Oaks Recreation Inventory and Variety

In total, Three Oaks features six (6) public recreation facilities, with over 34 acres of land and a series of non-motorized pathways / trail systems. The Village's parks and recreation facilities each have different types of amenities and opportunities for a wide variety of recreation experiences.

The following inventory and the Parks and Recreation Facilities Map detail the amenities currently available at each facility and the facility's respective location.



CHAMBERLAIN DOWNTOWN POCKET PARK

Classification: Mini-Park Accessibility: Level 4

Chamberlain Path is a small park in the heart of downtown Three Oaks, featuring an ever changing collection of sculptures provided by the Harbor Country Public Arts Initiative. An artistic large Kaleidoscope has been placed in the park for viewing.

The Path connects Elm Street and Generations Drive. Chamberlain Path has an attractive walking path and improved landscaping, updated in 2015. Eight (8) planters were placed in the park and local volunteers plant these annually.

There is an open-to-traffic driveway on the south side allowing traffic to drive through, park and visit the Region of Three Oaks Museum, The Acorn Theater and The Journeyman Distillery. There is also frequent pedestrian activity along Chamberlain Path and Generations Drive. Space for future improvements, including the potential incorporation of public restrooms is available within this area.



DILLARD PARK

Classification: Mini-Park Accessibility: Level 2

Dillard Park is a mini neighborhood park, located on the north side of town at the corner of Cherry and Walnut Streets. It has been generally well-used through its life and is a staple of the neighborhood. In 2011 and 2016, all equipment has been replaced with a play gym for 2-5 year olds and swing set for older children.

Planters have also been built by the Department of Public Works (DPW). One of the planters houses trees for Three Oaks to plant when needed. The first were used in 2016 along some Village streets. Four (4) large planters were placed to create a natural barrier for playing children, which were planted by the local volunteer garden club. Signage, benches and picnic tables were placed for visitors which include handicapped accessible picnic tables.

As a result, Dillard Park is always busy with kids and families enjoying the outdoors, swinging, climbing and tossing balls. All of these upgrades re-established the park as a quality mini-park for use by area residents and children.

Dillard Park was a donation from the Dillard Family to enhance the quality of life for residents and visitors.





DEWEY CANNON PARK

Classification: Neighborhood Park

Accessibility: Level 3

Site of the historic Dewey Cannon monument to the Spanish-American War, which was famously dedicated by President William McKinley himself, Dewey Cannon Park is Three Oaks' most historic recreational facility. In the summer, the park plays host to a weekly volleyball league and a concert. It serves as a trail head to many recreational bike rides for the regional bikepath system. Its central gazebo is used for weddings and other gatherings, as well as community events.

The not-for-profit community organization, the *Art and Education Center*, has taken over and remodeled the former Village office building at the north end of the park. They have built out an open-air theater from the Center, opening into the park. Built to host drama, film and music, this addition gives expanded options to those already available at the central gazebo. Two new bicycle racks have been placed at the west edge of the park, convenient to the Three Oaks Bicycle Center. The donating families have recognition plaques on the racks. New benches and tables are already planned for the summer activities, to replace the former, well-used ones.

The park is in need of some improvements, however. The electrical service to the gazebo needs an upgrade, and will be taken care of this year. There are no rest-rooms, although portable toilets have been available through the spring, summer, and fall seasons. The drinking fountain and barbecue grills are inoperative and in disrepair. There has been some talk about planting landscape screening at the edge of the park to separate the park from the commercial property on the east side. This has not been decided because many like the iconic, rural look of the facility.

This central park also suffers from drainage issues: during significant rain events and snow-melt, large puddles form throughout, limiting the use of the facility. This should also be addressed to improve the function of the park.





CARVER MEMORIAL PARK

Classification: Neighborhood Park

Accessibility: Level 4

Situated at the corner of Elm and Ash Streets, Carver Memorial Park is the gateway entrance to the village, but, for years was forgotten and underutilized. Named Carver Park in the 1970's it is dedicated to Three Oaks' only Vietnam fallen soldier, Randall Carver. Now considered the memorial park, it contains memorial and historical markers. Newly added is the 'fallen soldier monument'. The existing historical markers have been repaired, cleaned and resituated for better display.

The redesign and updates to Carver Memorial Park over the past five years have truly created a beautiful area that acts as a community gathering place and outdoor event space.

Today, the pavilion is complete, and hosts private and public gatherings, including the annual tree lighting event in December and Art in the Park during Flag Day celebration. A new sculpture was added by Harbor Country Public Arts Initiative, named "Bicycle Bob" in recognition of the Apple Cider Century and support of bicycling in the area. Pathways and landscaping have been added, with more landscaping planned, and the new benches along the paths encourage gatherings. No longer is the park underutilized and forgotten.


Future improvements consist of a planned visitor information kiosk, as well as a park entry sign. To complete the park and enhance its function as a gathering place, a public restroom facility is still a much needed amenity. At completion, Carver Memorial Park will truly be a year round asset to the community as envisioned five years ago.

ACCESSIBILITY RANKINGS

Providing accessible facilities that may be utilized by persons with varied disabilities is one of Three Oaks community goals. Each Village owned recreation facility was evaluated for compliance to the ADA Standards of Accessible Design by McKenna. Recreation facilities are rated on a 1-5 scale, as defined by MDNR:

- 1 None of the site elements meet ADA accessibility guidelines.
- 2 Some of the site elements meet ADA accessibility guidelines.
- 3 Most of the site elements meet ADA accessibility guidelines.
- 4 The entire recreation facility meets ADA accessibility.
- The entire recreation facility was developed / renovated using the principles of universal design.

All of the Village's facilities have accessibility ratings of 2, 3, or 4. While most of the recreation facilities include elements that are handicapped accessible, many of the routes to reach such facilities are lacking in compliance.

WATKINS PARK

Classification: Community Park

Accessibility: Level 2

Watkins Park is by far the largest park in the Village. Located on the southwest side of town at the end of Nel's Drive south of Locust Street, it features a playground, baseball fields, basketball hoops, pavilions and party space, and The Hoadley Nature Trail.

Cooperating with the Berrien County Drain Commissioner, Friends of Harbor Country Trail and the Rotary Club, plans are being developed to connect the Hoadley Trail and Schwark Wetlands area into the Berrien County Hike and Bike trail plan. Once accomplished these trails would connect Three Oaks Township Conservation Area Trails with current trails throughout the County and beyond. The trails have recently been greatly improved through a partnership with the Village of Three Oaks and the Harbor Country Rotary Club. Both Watkins Park and Hoadley Trail property were donated by the respective families to enhance the quality of life for Three Oaks residents and guests.

The baseball fields are the home to Three Oaks Little League, a popular spring and summer activity which involves much of the community. The two smaller fields, for 9-12 year olds, feature floodlights, and are in good condition except for some needed maintenance on the dugouts. The larger field, for 13-14 year olds and older, is in some need of updating, including re-defining the limits of the dirt infield. It also does not have floodlights.

The basketball hoops themselves are in good condition, except for needed net replacement (which is common for outdoor courts). The hoops are underutilized, however, because the court is used for parking and is filled with cars on little league nights.

The playground is built in the "timbertown" style, with wooden towers interconnected by tunnels, bridges, slides, and other playscapes. For most of its life it was well-maintained, but it has recently become the target of vandalism and negative behavior. A group of community members organized to build the playground in the mid-1990's and could be remobilized for the necessary repairs and updates. The playground is not well lit and there are many enclosed spaces, which could contribute to the vandalism. In addition, the timbers are showing effects of age and poor maintenance.

The park has two pavilions and an indoor party space that the Village rents out to community members. There is also a restroom facility, although it is not open to the public on a consistent basis.

The Schwark Drain Wetlands and the Hoadley Nature Trail, incorporated within the boundaries of Watkins Park, could become the focus for expansion of several environmental and recreational activities in the future.



NON-MOTORIZED PATHWAYS / TRAIL SYSTEM

Classification: Non-Motorized Pathway / Trail System

Accessibility: n.a

Three Oaks is the center of a network of 12 regional bikeways. The 5-mile Spring Creek Trail stays close to the Village, while longer trails like the Grand Mere Trail, the Posey Hill Trail, and the Warren Woods Trail stretch to distant destinations – the Lakeshore, Indiana, and Warren Woods State Park, respectively. The bike trails provide the routing for the annual Apple Cider Century, and they are popular with locals and visitors alike.

Additional Recreational Facilities

COMMUNITY GARDENS FACILITIES

The Community Garden was established in 2011 with Three Oaks Township's grant from The Pokagon Fund. It is located on township land, behind the River Valley Three Oaks Elementary campus, south of the railroad tracks and just east of the old historical Three Oaks train station.

It is a true "community" garden. Village resident volunteers manage participation of gardeners, educational and celebratory events held over the seasons, and maintenance of the grounds. The local garden club volunteers maintain flower beds surrounding the garden fencing. The Village supports the garden with funding for soil, organic tea applications and general maintenance needs. The Township supports the garden with funding for water, tools and equipment, and insurance. The River Valley schools are engaged with pre-school through 5th grade students planting, maintaining and harvesting six (6) beds. Volunteers help the students plant seeds each season using grow lights for germination. Teachers include the plantings in their curriculum and each student takes home a plant in spring, with the remaining plants being planted in the beds or sold to support their gardening efforts. Each year volunteers and teachers use some the harvest for a soup party with the students.

The entry is graced with Little Free Library #24908 in the entry klosk. Seating in the entry shelter allows visitors to sit and enjoy the garden or read in a natural setting. A rain garden collects water and provides habitat for pollinators.







NON-VILLAGE RECREATION FACILITIES

Within the confines of the Village, there are also two other recreational facilities. The American Legion fields, along Memorial Drive near Linden Street offer baseball and softball facilities. Three Oaks Elementary School, at Ash and Hickory Streets, has playground equipment and the only field in the Village suitable for soccer, lacrosse, or football. The playing fields surrounding the elementary school are partially owned by the River Valley School District and partially owned by Three Oaks Township.

THE COUNTY, STATE AND PRIVATE RECREATION FACILITIES

The region surrounding Three Oaks is well supplied with parks of various types. Directly southwest of the Village limits are new trails on W. Forest Lawn Road at the Kesling Conservation area. Across the state line is Indiana Dunes National Lakeshore, which offers lakefront beaches and sand dune recreation. Other Lake Michigan beaches include Grand Mere, Warren Dunes, and Indiana Dunes State Parks, while both Michigan and Indiana have inland State Parks in the region – Warren Woods in Chikaming Township, Michigan, and Potato Creek in North Liberty, Indiana.

The larger metropolitan areas in the region, such as South Bend, Michigan City, and Benton Harbor-St. Joseph, feature parks of their own, including the St. Joseph County Fairgrounds in Mishawaka, Potawatami Park and Zoo in South Bend, Indiana, and Silver Beach in St. Joseph, Michigan. Additionally, Three Oaks Township has new trails built off Kesling Preserve on Forest Lawn Road.

Three Oaks does not provide formal recreational programming for its residents, but there are several options available through adjacent communities and private providers.

Recreation Systems Analysis

COMPARISON TO STATE AND NATIONAL STANDARDS

The type of parks and their location, number of amenities, and distribution throughout the Village are all components that are assessed together as a recreation system analysis. The following comparisons are made between Three Oaks population and the state and national standards for service areas, acreage, and number of facilities.

Overall, Three Oaks has a strong formal parks and recreation system and within the last five years, has made considerable efforts towards improving recreation facilities and making them more accessible to neighborhoods and other community destinations.

SERVICE AREA ANALYSIS

MDNR establishes a recommended service area for each park classification to identify areas in the community that are lacking access to recreation facilities. The service area boundary for each type of park is as follows:

Mini-Park Neighborhood Park Community Parks >0.25 mile walkability service radius 0.25 – 0.5 mile service radius 1.0 mile service radius

As illustrated on the Park and Recreation Inventory and Service Areas Map, Three Oaks formal park system extends to the majority of the Village's existing or planned neighborhoods, especially within the downtown core and most of the north side of the Village. This is considered exceptional park service as individuals living within these areas have at least walkable access to two or more park facilities. However, several neighborhoods are outside of this walkability range, especially within the southeast portion of the Village. Building upon the existing non-motorized / trail system and linking neighborhoods to parks is one way to improve access and expand recreation opportunities for residents without the creation of an entirely new park facility.

ACREAGE ANALYSIS

Table 3.3 evaluates Three Oaks' park acreage to national guidelines for Michigan communities. As a state-wide measure, these standards are general in nature and do not always reflect the quality of the facilities, the character of the community, or other local differences that impact community recreation facility needs. Thus in evaluating the results, the actual conditions and trends present in the Village must be accounted for.

Even so, as a baseline indicator, Table 3.3 highlights the surplus of all park land that is available to residents. In addition, the presence of the Non-Motorized / Trail System throughout the Village provides additional access to parks and active recreation. Overall, the land dedicated and reserved for parkland in Three Oaks far exceeds minimum standards.

FACILITIES ANALYSIS

Additionally, MDNR recommends a certain number and type of recreation facilities for a community based again on its population size. Table 3.4 compares Three Oaks recreation facilities to the MDNR standards. Although the Three Oaks Elementary School, and other institutional recreational facilities, are within Village limits, they remain part of the River Valley School District and thus, were not calculated in the Villages facility count. However, it is important to note that these institutional facilities, including Three Oaks Elementary and the American Legion, are heavily utilized by members of the community and a popular destination for Three Oaks residents.

Considering Three Oaks 2015 population of 1,598, the Village has done an outstanding job of exceeding MDNR standards for several types of applicable recreation facilities. Again, the surplus of recreation amenities would only be greater if the count included the many active recreation facilities that belong to the River Valley School District and other institutions. As such, it is recommended that collaboration is continued with the School System and other entities, including the Township, in order to provide residents with even greater access to recreation facilities. Additionally, the Village may consider expanding the access to such facilities in order to create more inclusive environments for residents and visitors.

THREE OAKS' STRATEGY

Goals and objectives formulated by the community are the cornerstone of the recreation planning process as they form the framework for public and private decision-making. The purpose of this Plan is to provide a basis for public policy decisions and technical coordination in recreational development and to inject long-range consideration into the determination of near-term actions.

The goals and objectives, as outlined in this chapter, were developed through the Parks and Recreation Board and Village Administration, incorporate park and recreation best practices, and were confirmed by the results of the public engagement process.

Three Oaks' strategy hinges on its ability to provide a variety of parks that are flexible spaces to serve multiple users, creating an inclusive space for the community to enjoy.

This chapter details the public engagement process and key results and establishes the Village's goals and various corresponding objectives.

Public Engagement Process

Community participation brings vitality to a Parks and Recreation Plan and thus, the following pages detail the Village's public engagement process and feedback, and the resulting themes, goals, and objectives. To solicit public input, the Village hosted a online survey during the month of December, 2016 which was publicized by the Village Administration and Parks and Recreation Board. Approximately 60 individuals responded to the survey and submitted feedback.

Key Survey Results

Respondents were asked a series of questions pertaining to the existing quality of park areas (appearance, maintenance, and cleanliness), use of existing facilities, improvements, and priorities for Three Oaks park and recreational facilities. Key results of the survey are detailed below with full results included in the appendix. A majority of respondents (68 percent) were from the Village with the remaining 32 percent from the Township (10 percent) and other surrounding communities (22 percent).

VISITS TO FACILITIES IN THE PAST YEAR AND CONDITION RANKING

The majority of respondents that live within the Village or Township of Three Oaks most often visit parks within the Village, as opposed the Township or elsewhere. This indicates the Village's parks provide a critical service to not only Village residents but those in the Township and surrounding communities.

On average, Village Parks are visited between 6-10 times per year by households while almost 40% of respondents indicated parks are visited more than 11 times per year.

The most popular visited parks and recreation facilities within the Village in the past year are listed below, along with the most popular mode of travel when visiting (drive, walk, bike):

COMMUNITY GARDENS

An overwhelming 100% percent of survey respondents supported the idea of Community Gardens within Three Oaks and only 5 percent were not aware that the Village currently has a Community Garden near the Three Oaks Elementary School.

However, just over half (51 percent) of respondents were not interested in participating in the Village's Community Garden. 17 percent of respondents indicated they would need additional information on what a community garden involves and the benefits of such participation. This indicates educational outreach may be helpful to encourage greater involvement.

NON-MOTORIZED PATHWAYS AND THE TRAIL SYSTEM

Over 50 percent of survey respondents indicated that they use existing trail system often and occasionally. An additional 35 percent stated they were not aware of the existing trail system. This is further supported by the fact that 47 percent of trail users stated it is difficult to find and access the trail system within Three Oaks, noting more publicity and maps is needed.

Similar to the community gardens, promoting awareness and the addition of wayfinding signage to convey the availability of the trail system amenity may help to increase usership.

Additionally, 83 percent of respondents support the extension and connection of the Village's trail system to other local and regional trails.

PARK AND RECREATION PRIORITY INVESTMENTS

The following areas were ranked by priority of Village investment over the next five years:

- Creation of a Dog Park
- New Playground Equipment
- Expansion and Enhancement of Nature Areas
- Expansion and Enhancement of Walking Trails
- Sledding Hills
- Design and Implementation of New Park Signage

Improved access to park space or additional recreational facilities within the southeast quadrant of the Village is also a priority for future investments as only 42 percent of survey respondents felt this area is sufficiently serviced by parks and recreation facilities.

ADDITIONAL FUNDING FOR VILLAGE RECREATION FACILITIES

Survey participants were asked if they "would support an additional 0.5 mills in property taxes" for various parks and recreation improvements. Areas of parks and recreation which received more than 50 percent of respondents indicating they would support or strongly support an additional 0.5 mills included:

- Maintaining, upgrading, or improving existing parks (73.68%);
- Constructing new walking trails and sidewalks (64.29%); and
- Creating parks on vacant land (53.57%).

It is important to note that a response category for "neutral" was available for this question, which, in the case of maintaining, upgrading, or improving existing parks, shows that only 5.26% of respondents actually disagreed with such a millage.

Community Goals and Objectives

Goals, as related to community planning, are general statements of ideals toward which the Village strives towards. They also express a consensus of community direction for public and private agencies, groups, and individuals, and are long-range considerations that guide the development of specific objectives and actions.

Objectives are a means to achieve goals and identify the methods by which the goals of the Parks and Recreation Master Plan may be realized.

The stated goals and objectives are grouped according to major community themes and developed using feedback from the public engagement surveys and the Parks and Recreation Board.

GOAL #1:

Non-Motorized Connectivity -

Improve non-motorized connectivity in the community.

Objectives:

- Identify and pursue funding for additional sidewalks, trails, and pathways.
- Provide connections to parks, neighborhoods, and major areas of activity.
- Coordinate non-motorized planning with neighboring communities and Berrien County.
- Improve signage and access to non-motorized facilities.
- Utilize natural features areas as connections where possible.
- Create a better pedestrian crossing at railroad tracks and Elm Street.
- Provide a trailhead facility at junction of bike / nonmotorized trails with amenities for users including items such as but not limited to restrooms, showers, lockers, water, vending machines, etc.

GOAL #2:

Existing Facilities Maintenance and Improvement –

Continue to maintain and improve existing parks and recreation facilities

Objectives:

- Provide continuous improvements and maintenance to Village park facilities and equipment to return them to working, well-maintained condition.
- Implement a Village Parks specific maintenance program
 that would include the maintenance and upgrade of
 equipment and trail ways as well as restoration and
 maintenance of Historical Markers and Landmarks.
- Identify and provide funding for annual improvements to community facilities that maintain or exceed current levels.
- Adhere to high standards of maintenance for all parks and recreation facilities.
- Continue to improve safety and accessibility at parks.
- Explore opportunities for the "greening" of the parks and facilities through improvements such as field maintenance, reestablishment of native plantings, stormwater improvements, lighting upgrades, and energy audits.

GOAL #3:

Park Land Acquisition and Development -

Explore opportunities and provide funding for park site and land acquisition.

Objectives:

- Expand existing parks through the acquisition of available lots adjacent to or close to existing parks.
- Consider acquisition of sensitive environmental lands and natural resources for passive use or preservation.
- Acquire property or an existing building that would accommodate the construction of a Community and Fitness Center offering recreational activities to all ages.

GOAL #4:

Expand Amenities and Facilities at Village Parks –

Maximize use of existing park sites by expanding facilities and amenities available to residents to further increase quality of life for residents and further encourage others to visit and stay in Three Oaks.

Objectives:

- Include a broad range of facilities within each park where feasible, particularly addressing amenities and facilities currently lacking within the community.
- Develop park sites to their optimal use in consideration of changing community needs and resource limitations.
- Maintain a logical balance between active and passive pursuits in the parks.
- Develop covered gathering areas for festivals and events at downtown park site(s).
- Provide ancillary facilities to enhance the sites such as all season water fountains, grills, electricity outlets, controllable water sources, bleachers (at sports fields), and public restrooms.
- Provide facilities for activities currently not provided in the community, such as tennis, volleyball (permanent), bocce ball, horseshoe, campground, and a dog park.
- Provide for winter season recreation, such as an ice rink with warming hut with restroom facilities and/or facilities for cross country skiing.
- Continue to build and expand the community garden.
- Utilize parks as signature facilities in the community and incorporate gateways into Village and downtown.
- Provide activities in community for youth and teens.
- Coordinate with Three Oaks Township and Harbor Country communities on regional recreation issues and trail connections

GOAL #5:

Serve All Populations with Parks and Recreation -

Provide a range of parks and recreation facilities to meet the leisure needs of all segments of the population.

Objectives:

- As Three Oaks continues to develop, ensure that the Village population continues to be served with a uniform distribution of facilities, in terms of both geography and population.
- Develop facilities to meet the physical needs and ability levels of all park users, including improving the accessibility of existing facilities.
- Provide facilities and amenities for park users of all ages.

GOAL #6:

Preservation of Natural and Cultural Resources –

Protect natural and cultural features, such as wooded areas, wetlands, wildlife habitat, natural drainage ways, and historic structures and facilities.

Objectives:

- Identify important and recognized natural features and open spaces in the community.
- Preserve natural features within park sites to the maximum extent feasible, in consideration of the proposed multiple-use character of the Village's parks.
- Develop programs and utilize sites in a manner that results in a greater appreciation of the community's natural resources.
- Incorporate natural and historic resource protection, including protection of groundwater recharge areas, into the parks and recreation program whenever the opportunity presents itself.
- Identify funding for upgrades and maintenance of historic facilities in the community.
- Conduct Natural Features Inventory within next five years to identify high priority sensitive areas for planning purposes.

GOAL #7:

Funding -

Develop stable sources of funding and practice sound fiscal management of the parks and recreation system.

Objectives:

- Pursue all available funding sources for capital improvements and operations and maintenance, including local sources, a parks and recreation millage, state and federal grant programs, local businesses, community organizations, and other sources.
- Explore opportunities for greater private sector participation in the provision of recreation and leisure services in the Village.
- Coordinate efforts with local interest groups and recreation providers and create partnerships for providing these resources throughout the region.
- Develop long-range projections of costs and revenues as a management tool.
- Explore developing a more complete fee structure for the use of community park facilities; update the existing fees to be competitive with regional facilities; and review the fees on an annual basis.







PLANNING FOR CHANGE

Three Oaks' Action Plan serves as a template for future projects and is intended to be a flexible, year-by-year list of improvements for 2017-2021. The Action Plan supports the goals and objectives for the Village development, growth, and enhancement through a comprehensive set of network improvements, policies and programs that are staggered over the five (5) year period.

Within this chapter, projects are identified which will develop the Village's recreation system in a manner that provides a total recreation experience for the entire family. With the goal to continually develop facilities for active and passive recreation, competitive sports, for children, adolescents, and seniors, and picnic and gathering spaces, and natural landscapes, Three Oaks will continue to afford residents and visitors a high-quality park and recreation experience.

Detailed on the next several pages is Three Oaks' Action Plan, top five (5) projects for prioritization, and project descriptions to help guide and inspire responsible parties towards a common understanding and lay the groundwork for implementation.



Top five Priority Projects

The following five (5) priority projects represent near-term investments that have the potential to create major and immediate improvements to the Village's parks and recreation system.

These top five projects were identified by Village Administration and the Parks and Recreation Board and serve as an excellent starting point for future prioritization and action:

- Dewey Cannon Park Improvements
- Watkins Park Improvements
- Chamberlain Pocket Park Improvements
- Carver Park **Improvements**
- Joint Three Oaks Partnerships

Full project descriptions are detailed on the following pages.

Action Plan

Three Oaks' Action Plan is detailed in Table 5.1 which presents each of the proposed project titles, the anticipated time frame, estimated cost range, and potential funding sources / partnerships. Some park facilities contain various projects that are planned to occur over multiple years and involve coordination with other agencies. Other park and recreation facility projects involve targeted improvements that Three Oaks can implement quickly within one year and/or with the help of volunteers.

Cost range estimates for Three Oaks' Action Plan projects were derived in 2016 dollars and are strictly preliminary. Actual costs for each project should be specifically determined with the aid of site surveys, programming elements, and engineering requirements. If funding levels are lower than required to implement the project based on the schedule provided, the project's implementation time frame could be stretched over additional years or the scope of the project condensed.

Projects of the Action Plan should be reviewed annually by the Parks and Recreation Board and reported to the Village Council, allowing for adjustments to respond to updated needs / conditions and the identification of funding opportunities.

Project Descriptions

PARK MAINTENANCE AND FUNCTION

The Village of Three Oaks is fortunate to have a quality parks system with a wide variety of amenities dispersed throughout the community. To continue restoring parkland and maintaining existing facilities and amenities, the Village anticipates creating maintenance plans with responsibilities of each entity involved to ensure that the community is enjoying the full benefits of Three Oaks recreational assets.

NON-MOTORIZED PATHWAY / TRAIL SYSTEM CONNECTIONS

The Village of Three Oaks is committed to providing pedestrian and bicycle pathways and connections throughout the Village and beyond. The Village should continue to develop pathways and connections, particularly linking the parks and recreation and Village facilities, as well as residential areas. A Village-wide plan for a multi-modal trail system is proposed, including bicycles, pedestrian, snowmobiles, and others incorporate local, County, State, and other trail systems to ensure maximum connectivity.

JOINT THREE OAKS PARTNERSHIP

Three Oaks Village and Township have established an improved, working relationship for the planning and management of their Parks and Recreation Boards, to maximize benefits for the Village and Township residents, who all enjoy the parks and recreation facilities of the area. There is some momentum to combine the Village and Township Parks and Recreation Boards, which would streamline, organize the parks system for the entire community, and potentially result in reduced costs as a result of shared services. Together, the Village and Township can further enhance recreation amenities

EXPAND AND PARTNER FOR RECREATION FACILITIES

Investigate the possibility of providing new recreation facilities in schoolyards and the parks of other local jurisdictions that will be available to all residents of the Three Oaks Area, including: the River Valley School District recreation facilities and county and township parks in the Three Oaks Area; and provide opportunities for a healthier lifestyle through exercise. Strongly work with local service organizations.

CHAMBERLAIN DOWNTOWN POCKET PARK IMPROVEMENTS

Located within the downtown core, continued development to the Chamberlain Pocket Park will provide the Village with a centralized gathering space for community events and further enhance the overall character and public image of Three Oaks. Improvements include additional landscaping, signage, seating, public restrooms, public art (cleaning and feature pieces, decorative pavement treatments, and landscaping screening (to provide a greater transition from the adjacent commercial / parking areas). Strongly working with local service organizations and the Downtown Development Authority (DDA) is critical for the success of this project.

WATKINS PARK IMPROVEMENTS

Design and implement park improvements, including:


- Repairs to the Little League Fields (equipment and electrical upgrades);
- Repairs and replacement of broken equipment in Timber Town;
- Repairs to the existing station fitness course;
- New picnic and gathering spaces;
- Shared-Use path improvements (see project details below), including a connection to the bike trail system on Elem Street via Locust with street markings as "shared use"; and
- Addition of multi-purpose tennis and basketball courts.

The Village, with support from the Masonic Lodge and others, has made significant recent investments, including the construction of a covered, outdoor pavilion with a series of picnic tables underneath and a fireplace to afford residents and visitors with year-round community gathering activities.

CARVER MEMORIAL PARK IMPROVEMENTS

The centralized location of Carver Park and its current programming has made it an ideal site for universal access improvements and an expansion of recreational amenities. The overall design concept for an improved Carver Park is the finalization of an inclusive, universally accessible community gathering space with recreational amenities to attract a variety of users and ages.

Outstanding park improvements include:

- WAYFINDING KIOSK. Installation of a wayfinding kiosk to inform both residents and visitors of the park and its amenities and surrounding Village with other recreational destinations to help individuals experience other Three Oaks attractions. Wayfinding signage is a component that was budgeted in the most recent Capital Improvement Plan.
- RESTROOM FACILITIES. Construction of restroom facilities will allow park users greater enjoyment of the space for longer durations. The restroom facilities will feature more than the minimum number of accessible units to ensure there are sufficient facilities available during community events. Additionally, a second water fountain designed for universal access and with sensors to avoid the waste of water resources is also located just outside the restroom facilities.

LANDSCAPING UPGRADES. Additional vegetation in various groupings around the pathway system will create a series of both formal and informal gardens for wildlife and viewing. Native vegetation will be incorporated into the design. The gardens provide an excellent opportunity for youth to connect with nature in an engaging and educational manner. Visitors can also enjoy the gardens, both aesthetically and educational as signage will be provided. Evergreen trees are also planned to increase the overall amount vegetation and on-site species diversity.



DEWEY CANNON PARK IMPROVEMENTS

Design and implement park improvements, including:

- Electrical upgrades;
- Landscape upgrades;
- · Addition of a drinking fountain.

DILLARD PARK IMPROVEMENTS

Design and implement park improvements, including:

- Addition of a drinking fountain; and
- Best management for stormwater drainage.

WATER RESOURCE MANAGEMENT

Create, ingrate, and maintain blue and green infrastructure centered around the Village's water systems that aims to improve the water quality (including algae removal, water flows and levels) so that they remain healthy and attractive. Acquire and preserve greenbelts of land around water systems to protect the watershed from development impacts and pollution and collaborate on regional projects to address environmental quality.

PARKS AND RECREATION MASTER PLAN UPDATE

Update the Parks and Recreation Master Plan every five years (2022 deadline).

PARK WAYFINDING AND SIGNAGE PLAN

Continue to design and implement wayfinding signage at all parks, following a consistent theme that ties into the existing Three Oaks theme. All trail signage should include a map with routes and incorporate travel times for each segment to help guide unfamiliar users and any wayfinding signage program must consider parking and Village destinations.





Q2 If you live within the Village of Three Oaks, do you most often visit parks and recreation facilities in the Village or Township?











- Approval of the Consent Agenda to include: Approval of Minutes from the Regular Council Meeting on 01-11-17. Approval of Invoices to be paid (\$38,855.19), Approval of Disbursements made from January 1 through January 31, 2017 (\$95,554.51), Approval of Prepaids, and Payroll as paid (\$32,952.37), and the Treasurer's Report. - VEHICLE BIDS for DPW & POLICE DEPARTMENT: Due to some confusion on the specifications for the DPW vehicle, it will need to be re-bid. Those bids will be solicited and the information will be available at the March meeting. There were (2) two bids received and opened on January 25, 2017 for the Police vehicle. Chief Dennis Buller prefers that the replacement vehicle be a 4-door truck. Siemans Ford presented a bid of \$29,243 and Three Oaks Ford submitted a bid of \$29,325. Adam will check with other police departments that are currently using this type of truck to see if they are happy with it before submitting the low bid from Siemans Ford to Council for approval at the March meeting. The Village will pay cash for the new vehicle out of funds that have already been allocated.
- BIDS for 2017 STREET PAVING PROJECT: (2) bids were received and opened on February 7, 2017 for the 2017 Street Paving project. Rieth Riley's bid was \$106,621.52 and Michigan Paving's was \$125,776.28. It was decided that since bids came in much lower than expected, additional street work could be done. It was decided to do (2) additional blocks of Hickory and (3) additional blocks of Cherry. A change order for the extra work was submitted in the amount of \$29,117.89. A Motion was made to approve the low bid from Rieth Riley for street work on Butternut, Sycamore, Walnut, Chestnut and Buckeye Streets, and on North Elm (from the train tracks to Sycamore) in the amount of \$106,621.52 and Change Order #1 from Rieth Riley in the amount of \$29,117.89 for (2) blocks of Hickory and (3) blocks of Cherry for a total amount of \$135,739.41. This work is projected to be completed before Flag Day weekend. - **SEWER PONDS DREDGING:** Prior to getting bids for dredging the Sewer ponds, there must be a "residual material plan" in place with the DEQ. Edgewater Resources, (an engineering firm), is working with the DEQ to get one done, however, it may take up to 3 months. Once it is complete, bids can be solicited for the dredging.
- **SEWER PONDS STUDY:** Testing has been done to determine what is going into the Sewer ponds and to determine if something is infiltrating the ponds other than what is going thru the pipes. The results of the study have not been received yet.
- CAPITAL IMPROVEMENT PLAN: Projects need to be identified so that money can be set aside and allocated. A priority item would be a study of the Water Plant.
- JOINT PARKS BOARD DISCUSSION: Three Oaks Township is interested in discussing the possibility of a joint Parks Board. By creating a joint board, it would make it easier to pursue grants and be easier to market & coordinate projects using grant money. There currently is a Township member with voting privileges on the Village's Parks & Recreation Board. There needs to be further discussion about pursuing this idea.

- ADOPTION of PARKS and RECREATION PLAN: The updated (5) year Parks & Recreation Plan for 2017-2021 (with changes as noted for McKenna & Associates) was presented at the Public Hearing meeting prior to the Council meeting. This Plan must be submitted by March 1, 2017 to MDNR in order to remain eligible for state funding/grants. A Motion was made to adopt the (5) year Parks & Recreation Plan for 2017-2021 (with changes as noted to be made by McKenna & Associates) prior to submitting the Plan by March 1, 2017 to MDNR.
