ORDINANCE #221

**An Ordinance to Amend Ordinance #219-The Village of Three Oaks Regulation of
Medical and Adult Use Marihuana Ordinance**

The Village of Three Oaks ordains:

Section 4., B., AUTHORIZATION AND FEE, of Ordinance No. 219, is hereby amended to read as follows:

SECTION 4 AUTHORIZATION AND FEE

B. The Marihuana Businesses and the number authorized pursuant to this Ordinance are:

Marihuana Retailer	2
Marihuana Microbusiness	1
Marihuana Class A Grower (100 plants)	3
Marihuana Class B Grower (1,000 plants)	3
Marihuana Class C Grower (2,000 plants)	3
Marihuana Processor	2
Marihuana Safety Compliance Facility	1
Marihuana Secure Transporter	1

Except as amended herein, all other sections and provisions of Ordinance #219, Village of Three Oaks Regulation of Medical and Adult Use Marihuana Ordinance, shall remain as previously adopted.
