

SELECTMEN and ASSESSORS MEETING SUMMARY  
September 30, 2015

*In attendance:* Select Board – Wesley Daniel, Duane Vigue and Berkley Linscott; CEO – Bob Temple; Town Clerk/Treasurer – Ann Dean; Public: Cathy Blake

Wesley Daniel called the meeting to order at 7:00PM.

Duane Vigue moved to accept the summary from 09/23/2015 as written, Berkley Linscott seconded, all in favor.

Duane Vigue moved to accept the warrants as written \$3,476.43/payroll and \$3,383.32/vendor, Berkley Linscott seconded, all in favor. Warrants read, approved, and signed.

Wesley Daniel reported on Public Works Report – 9/21 – 9/24 worked on P400 sander, P100 plow, P500 plow and painted P500 plow, cleaned up shop and put P400 plow in shop to be worked on. Duane Vigue moved to accept the Public Works Report as read, Berkley Linscott seconded, all in favor.

Bob Temple, as CEO, reported he issued two Shoreland Zoning permits. The Appeals Board meets tomorrow night and he will keep the Select Board informed. Bob will have wrist surgery in a few weeks and be ‘out of commission’ for 4-5 days following.

As Treasurer/Town Clerk, Ann Dean reported that the bank balance is \$964,107.90.

The Department of Labor Consultation Safety Works scheduled for November 9, 2015 to begin at 9:30am.

Duane Vigue is not able to attend the Drug & Alcohol Testing Seminar. Wesley Daniel will attend on October 22, 2015.

Now that Marr Cemetery is all marked Wesley Daniel asked Berkley Linscott to contact everyone who has purchased a lot and show them where their lot is located. Ann Dean will give Berkley a list of people who purchased plots.

#### Questions and Comments

Wesley Daniel will be gone from 10/6 to 10/13. He asked that either Selectman replace him on the two Tuesdays he will not be in the office.

Wesley Daniel explained that the fire department's rescue is going in to be refurbished this month. We have borrowed an ambulance chassis from Summerville (Jackman). The Select Board signed a Loaner Agreement for insurance. Wesley motioned to sign the Loaner Agreement for the borrowed ambulance, Duane seconded, all in favor.

The Select Board signed the 2015 Municipal Evaluation Returns for the Assessor, Stan Millay.

Kathy Blake asked if the plows need sharpening. Wesley Daniel said they use cutting edges on the plows.

#### Budget Work

The Select Board discussed a few categories of the budget. Wesley Daniel made a comment about the roads that we have not gone over and above what was planned because we started the paving program it was bought up over \$100,000. more. Wesley will ask Raymond Gushee to remove brush at some of the cemeteries.

Wesley Daniel adjourned the meeting at 7:46PM.
