

Selectmen/Assessor's Meeting Summary
March 2, 2016

In attendance: Select Board – Wesley Daniel and Berkley Linscott; Town Clerk/Treasurer – Ann Dean; CEO – Bob Temple; Public: Tom Johnston, Andrew Thompson

Wesley Daniel called the meeting to order at 7:00PM.

Berkley Linscott moved to accept the summary from 2/24/16 as written, Wesley Daniel seconded, all in favor.

Berkley Linscott moved to accept the warrants as written \$3,406.14/payroll and \$11,620.79/vendor, Wesley Daniel seconded, all in favor.

Public Works Report – Wesley Daniel reported for 2/21 – 2/27 –posted roads, worked in the garage, plowed, sanded and washed trucks. Berkley Linscott moved to accept the report as read, Wesley Daniel seconded, all in favor.

CEO Report – Bob Temple reported that he is working on one plumbing permit. The Planning Board will deliberate on the Linscott pit application next week. Request from Troy Hatch to remove the collision center from the table.

Town Clerk/Treasurer Report – Ann Dean reported that the town report was proofed and sent to print. She went to the Union Town Office to scan voter registration cards. Anker property, previously in bankruptcy, was auctioned off and taxes from 2012 were paid to date. About 144 30-day notices are going out tomorrow.

Wesley Daniel stated a letter was received from Fred Newcomb indicating that he cannot represent us for our involvement, if any, in the Janet Emery/Laura Billings case. He has to recuse himself because of a conflict of interest. He recommends Paul Givens if need be. Wesley will call Fred to let him know that if needed they will contact Paul.

Wesley Daniel stated that the Public Works Crew signed up for Work Zone Traffic Safety Class in April.

Marcus, from MMA, will be coming out Friday morning at 9am for Risk Management Renewal. Wesley Daniel and Berkley Linscott will meet with him.

Questions and Comments

Wesley Daniel read in an email from Mid Coast Planning Commission about a grant for stream crossing culverts from DEP. Wesley will call engineers Gartley and Dorsky who have information about the culverts.

Tom Johnston stated that there is some legislation going through that might affect the town regarding abandoned town roads.

Berkley Linscott asked if we, the town, had a Road Committee. Since September Ann Dean, Wesley Daniel and occasionally Chris Armstrong have gone out to view the roads and rate them in the new software. Ann stated we need a Road Committee and encouraged Berkley to get a committee together.

Ann Dean posted, on the website, where the absentee ballots are located a link to the duties of a Selectman according to the MMA manual along with our town practices. This will help the new Selectmen understand their duties and responsibilities.

Wesley Daniel adjourned the meeting at 7:14 PM.
