

Selectmen/Assessor's Meeting Summary
March 9, 2016

In attendance: Select Board – Wesley Daniel, Duane Vigue, Berkley Linscott; Town Clerk/Treasurer – Ann Dean; CEO – Bob Temple; Public: Tom Johnston, Sean Donaghy, Kit Lascoutx

Wesley Daniel called the meeting to order at 7:00PM.

Berkley Linscott moved to accept the summary from 3/2/16 as written, Duane Vigue seconded, all in favor.

Duane Vigue moved to accept the warrants as written \$3,554.89/payroll and \$17,731.34/vendor, Wesley Daniel seconded, all in favor.

Public Works Report – Wesley Daniel reported for 2/28 – 3/6 – 29th-1st chipped brush on Old Union Road; 2nd plowed, sanded and washed trucks; 3rd chipped brush on Old Union and Calderwood Roads. Duane Vigue moved to accept the report as read, Berkley Linscott seconded, all in favor.

CEO Report – Bob Temple reported Troy Hatch will be submitting an application for a collision center on his property. A request from Robert Marks that will be on the next Planning Board agenda, in April, regarding a sub-division line boundary adjustment.

Town Clerk/Treasurer Report – Ann Dean reported that last Thursday 142 30-day notices were mailed. Denise Hylton worked the caucus' over the weekend. Marcus met with Berkley Linscott and Wesley Daniel last Friday regarding insurance forms. Ann will be attending a computer security class on 3/15. Leticia worked with Stanley Millay to set up maps on the new computer. Ann's preparing for tomorrow's Worker's Comp audit. Ann spoke with Jake, The First, regarding the Trust Fund CD's coming due March 15 – Machias was giving us .27; The First will give us .94. Ann has posted, on the website, the door, and will announce at the town meeting that Sterling Ambulance no longer will provide emergency medical service and transportation – call 911. Steve Dean picked up the town reports and 2016 Annual Town Meeting Warrants. The Warrants will be signed tonight and posted tomorrow throughout town and online.

Duane Vigue moved to sign the pour permit for Washington General Store, Berkley Linscott seconded, all in favor. This will allow the store to offer a beer or glass of wine with a meal.

The Selectmen signed the Warrant for RSU40 April 5, 2016 Referendum.
