

Selectmen/Assessor's Meeting Summary
September 7, 2016

In attendance: Select Board –Tom Johnston, Berkley Linscott; Public CEO – Bob Temple

Berkley Linscott called the meeting to order at 7:00PM.

Tom Johnston moved to accept the summary from 08/31/16 as presented, Berkley Linscott seconded, all in favor.

Tom Johnston moved to pay the warrants as presented \$3,835.56/payroll, \$13,441.50 Berkley Linscott seconded, all in favor.

Public Works Report – August 29th & 30th Replaced culvert on Old County Road, ditched Sprague Road 31st replaced cross culvert in driveway and finished ditching Sprague Road. Tom Johnston moved to accept the Public Works Report as read, Berkley Linscott seconded, all in favor.

CEO Report – Bob Temple reported that he has not been able to personally contact Sukeforth. Bob will come back next week with the information received from the state regarding Sukeforth's violations. Tom Johnston expressed the need to move forward regarding these violations, to be discussed next week. Bob met with people from the Advent Camp after the fire to explain setbacks. He asked them to contact the Fire Marshall's office with questions regarding fire issues for replacing the buildings. He has also been working with the residents on Steele Lane and Sukeforth Lane regarding explaining the Shoreland Zoning. He has not issued any new permits.

Town Clerk/Treasurer Report – None.

The Town Property Survey done by Dan Whittier, MMA on 8/30/16 report came back without any safety problems, just keep up with the paperwork.

Maine Electric Power Company Transmission line section 388 Replacement will be looked over by Bob Temple to make sure they do not have to go through the Planning Board.

Questions and Comments

Cheryl Cichowski, School Board Member, is planning on attending a Selectmen's Meeting each month to help bridge the gap between town/school board. She encourages questions. Cheryl is on the Finance Committee which meets the first Thursday of every month. She will bring a more detailed report to the next meeting she attends. There have been great improvements in the district's finances since the new Superintendent and Business Manager have put together a new debt reduction plan. Cheryl touched on the prospect of the new building, to be voted on

in November, for Mid Coast School of Technology. The Superintendent is looking to raise the base level of salaries for staff to help with recruitment and longevity. The sports schedule has been published. This year's musical will be Cinderella. The administration is working, with anyone interested-including community members, on a Comprehensive Education Plan (which includes everything involved in the educational system). There are many extensive repairs, at the schools, that have been prioritized and are being done since the bond for repairs was voted on and approved. The air exchange system has been finished. There is other funding to obtain through the free/reduced lunch which Cheryl will touch on at another time.

Berkley Linscott adjourned the meeting at 7:26PM.
