

Selectmen/Assessor's Meeting Summary
March 28, 2018

In attendance: Select Board – Wesley Daniel, Tom Johnston, Berkley Linscott; Town Clerk/Treasurer – Ann Dean; CEO – Bob Temple; Public – Bill Cesario, James Burkner, Kit Lascoux

Wesley Daniel called the weekly Selectmen Meeting to order at 7:00 PM.

Tom Johnston moved to accept the summary from 03/21/18, Berkley Linscott seconded, all in favor.

Tom Johnston moved to pay the warrants as presented \$4,475.02/payroll; \$17,275.00/vendor, Berkley Linscott seconded, all in favor.

Public Works Report – 3/18 – 3/24: 19th – changed the cutting edge on P-500 and fixed the sander; 20th – one sick day and serviced P-300; 21st – did equipment inspection check list, checked equipment and greased and changed oil on P-200; 22nd – plowed and sanded. The winter sand screening should be done Friday. Time cards attached.

CEO Report – Bob Temple stated Peter Drum is still working on the Condon complaint. Bob will see Bill Bixby and Elmer Leigh this weekend to sign their Consent Decree or something different will be done. Bob has gotten requests to do Timber Harvest to the pond. Bob will look at these properties first. There is a request to put a tiny home on Old County Road; Bob will meet with her. Tom Johnston asked Bob if he would get Forestry involved regarding harvesting near the pond. Bob will contact them if there is an issue.

Town Clerk/Treasurers Report – Ann Dean reported that the Town Meeting went well. There were 91 voters for the election; 61 residents came to the town meeting to vote on Saturday. Ann and Mary Anderson went to the office right after town meeting to input all the budget numbers from town meeting. An issue that did come up is that we were given the wrong numbers for Union Ambulance. Tom Johnston will address the issue; there were two spread sheets involved. 1960 – 1971 record book was picked up by Bill Stewart from Kofile which has a lot of town meetings that need to be preserved. Lynn Carroll was in to resolve internet and printer problems in the office. Ann ordered tools for Jonathan. Sandy Patrick is taking minutes for the Select Board tonight.

Bill Cesario and James Buckner, representing CMP, were present to speak about the transmission replacement project inline with Tangents Energized upcoming April 11 – 25. It will be taken out of service to do the angle poles. They will work on 5 different structures west of Mountain Road. They want to get equipment up there on April 11. Bill would like permits to haul heavy load over Young's Hill Road from Route 105; bucket trucks and crane will be in and out – only two times on the roads. The wood timber mats will be hauled out during that time 75-90 trucks during that period of time. Tom Johnston asked how much of a bond would be posted to repair the road. Bill will check with CMP to get a letter of guarantee. Tom Johnston moved to require a letter of guarantee by CMP that we allow them to move equipment as they have

stated beginning April 11 ending on April 25 and to hold mats until the roads are not posted, Wesley Daniel seconded, all in favor. Bill will provide information regarding the truck permits.

Tom Johnston moved to add West Washington Cemetery to Ray Gushee's contract for Cemetery Maintenance, Berkley Linscott seconded, all in favor.

Wesley Daniel will call Scott from Second Nature Tree Service to schedule tree work for McDowell Cemetery.

There was some discussion regarding the School Board Budget. Dan Furrow was not available for questions. Dan will be here to explain the process next week.

Wesley Daniel moved to appoint the following people as ballot clerks, Glenice Skelton, Katherine Grinnell, Elizabeth Grinnell, Janet Martucci, Judith Brann, and David Studer, Tom Johnston seconded, all in favor.

Questions and Comments

Wesley Daniel moved to start the Road Crew on a 40 hr/week April 1, 2018, Tom Johnston seconded, all in favor.

Wesley Daniel moved to put down 800 ton for salt on the form, Tom Johnston seconded, all in favor.

Wesley Daniel stated Burton Orff was in the other day explaining a problem in Levensaler Cemetery ; someone has mapped out plots on someone else's. When the snow goes it will be taken care of.

Kit Lascoutx stated on April 16 the Comprehensive Plan Committee will meet. If anyone is interested in triage there are events going on in Rockport, April 19th and May 8th in Thomaston – more information to follow.

Wesley Daniel adjourned the meeting at 7:43PM.
