CEO Report:

Bob stated that there is very little information pertaining to RV's within the town ordinance. RV's are allowed with approval. Nonetheless, they are prohibited without a proper septic system and/or alterations to a septic system. Bob provided copies of a letter he wrote, which will be forwarded to the Old County Road property. The letter states the provisions and the specifications which need to be followed in order to be in compliance. He recommends amending the ordinance.

Bob has been receiving calls in reference to people wanting to put in campsites. He found within the ordinance that campgrounds are permitted (with Planning Board review) within the district. The general standards that apply are shore land zoning and site plan review.

He has been approached by someone who would like to use 40 acres of land for recreational use. They would like to provide horse and buggy rides. This will need to go to the Planning Board.
