Wesley Daniel Called the Selectmen's Meeting to order at 7:00 p.m.

Approve Summary of October 2, 2019: Motion to approve by Tom Johnston, 2nd by Berkley Linscott, All in favor.

Sign Treasurer's Warrant dated October 9, 2019:

Payroll Warrant #83- \$5,437.76

A/P Vendor Warrant #84- \$69,191.40 (includes ambulance and social services payments)

Road Foreman Report: Written by Frank Jones, Jr. and read by Wesley Daniel:

09/30/19 6:00am-4:30pm: Put up 808 yards of winter sand.

10/01/19 6:00am-4:30pm: Moved stone from winter sand and paint plow parts.

10/02/19 6:00am-4:30pm: Put up 231 yards of winter sand, ran out of salt; greased the loader; the ladder step broke on the loader, I fell off and cut my leg.

10/03/19 6:00am-4:30pm: Put up 565 yards of winter sand, so far we did 1604.

Wesley Daniel asked if there were any questions regarding the Road Foremen's Report and there were not.

CEO Report: Bob Temple stated that all of the pit inspections are done and the permits have all been paid. Bob is working on a list of the junkyard statutes to be used as a checklist during the inspections next week. The inspection warrants that have been forthcoming will be put in front of the judge tomorrow.

Health Officer Report: None

Town Clerk/Treasurer's Report: Mary Anderson stated that we are still working on getting the computers back to full strength. We bought a new computer and Lynn will come in on Tuesday to install it while the office is closed. The bank balance is \$1,124,960.86. The Road Crew will be taking Thursday off next week, instead of Monday for the holiday. 2017 back taxes have been paid in full, so there are no foreclosures this year. Mary and Joan will be going to Washington Manor for absentee voting October 23rd. Charlotte Henderson has asked if we could print some letters for the Washington Lakes Association when the Alewives are mentioned. Charlotte will provide the paper and the toner is included in the lease for the printer. The Selectmen approved this use of resources.

Other Agenda Items:

Wesley Daniel stated we received a rate lock for \$2.15 per gallon for heating oil through Maritime Energy that needed to be signed today to get the rate. He signed the agreement and sent it in.

Tom Johnston asked if we need to get the garage generator serviced. Wesley Daniel responded that the budget for the town garage maintenance account has already been expended. It was decided that it will be serviced in the spring.
