Wesley Daniel called the Selectmen's Meeting to order at 7:00 p.m.

Approve Summary of January 29, 2019: Motion to approve summary by Tom Johnston, Berkley Linscott 2nd, All in favor, Motion's carried.

Road Foreman Report: Written by Frank Jones, Jr. and read by Wesley Daniel:

1/26/2020 7:30am-12:00pm: I was called out to sand dirt road, I called in Kevin to help me.

1/27/2020 6:30am-4:30pm: We were called to sand for black ice; We washed off trucks and took plow and wing from P-300 off.
