7/02/2020: 6:30-4:30 We ditched on Young's Hill Road and Prescott Road intersection.

CEO Report: Bob Temple was not present due to inclement weather.

Health Officer Report: Not present.

Town Clerk/Treasurer's Report: Mary Anderson stated that there will not be a meet the candidate's night because ShaRon Kelly will be out of town until after the Election and Town Meeting.
